◆ **Eligibility Criteria:**

**For Category [Unreserved, Economically Weaker Section] & Passing Year [2024, 2023, 2022, 2021]:** Must Pass in Class 10+2 Exam And Minimum 75.00% Aggregate for Top 4 Subjects Excluding (Environment Studies, Environmental Education) in Class 10+2 Exam And Minimum 60.00% Marks in any of (Economics, Mathematics, Computer Application, Commercial Law And Preliminaries Of Auditing, Accountancy, Business Studies, Commerce, Costing And Taxation, Entrepreneurship, Informatics Practices) in Class 10+2 Exam And Must Pass in English in Class 10+2 Exam And Studied English for Minimum 100 Marks in Class 10+2 Exam.

**For Category [Scheduled Caste, Scheduled Tribe] & Passing Year [2024, 2023, 2022, 2021]:** Must Pass in Class 10+2 Exam And Minimum 56.25% Aggregate for Top 4 Subjects Excluding (Environment Studies, Environmental Education) in Class 10+2 Exam And Minimum 45.00% Marks in any of (Economics, Mathematics, Computer Application, Commercial Law And Preliminaries Of Auditing, Accountancy, Business Studies, Commerce, Costing And Taxation, Entrepreneurship, Informatics Practices) in Class 10+2 Exam And Must Pass in English in Class 10+2 Exam And Studied English for Minimum 100 Marks in Class 10+2 Exam.

**For Category [OBC-A, OBC-B] & Passing Year [2024, 2023, 2022, 2021]:** Must Pass in Class 10+2 Exam And Must Pass in English in Class 10+2 Exam And Studied English for Minimum 100 Marks in Class 10+2 Exam And Minimum 67.50% Aggregate for Top 4 Subjects Excluding (Environment Studies, Environmental Education) in Class 10+2 Exam And Minimum 54.00% Marks in any of (Economics, Mathematics, Computer Application, Commercial Law And Preliminaries Of Auditing, Accountancy, Business Studies, Commerce, Costing And Taxation, Entrepreneurship, Informatics Practices) in Class 10+2 Exam.

◆ **Merit Index Criteria:**

Percentile of Aggregate marks in Top 4 Subjects Excluding (Environment Studies, Environmental Education, Environmental Science) [10+2 Exam]. If any of the subjects (Environment Studies, Environmental Education, and Environmental Science) is studied as an Elective subject of 100 marks, it may be taken into account for the purpose of determining aggregate marks.

◆ **Selection Procedure: Selection of candidates will be made strictly on the basis of merit.**

List of valid applicants for the Morning Shift and Day Shift will be displayed separately in the admission website. For the purpose of rationalization, the aggregate marks shall be converted into percentile form. Applicants applying for either only Morning shift or only Day shift will not be allowed to change their preferred shift at the time of admission. However, applicants applying for both Morning and Day shift under single registration will be allowed to exercise their choice for Day or Morning shift, subject to availability of seats, at the time of submission of fees (online) for admission. For preparation of merit list, appropriate tie-breaking method shall be applied, if necessary.

◆ **Issue and Submission of Forms:**

The Application Form will be available online only. Candidates are advised to fill in the Application Form electronically (online). **In no case, filled-up forms will be received by the office of the College.** For electronic submission of the Application Form, log on to the online admission portal of the College: <https://ug.collegeadmission.in/Goenka/>.

### **Important Points Relating to Provisional Merit List and Admission**

1. Eligible and willing applicants must note the following at the time of applying online:
    - (a) Applicants must register themselves in the online portal by providing their information and uploading testimonials.
    - (b) After the registration, an applicant may apply for only Morning shift or only Day shift based on their preference.
    - (c) If an applicant does not have any specific preference with respect to shift, he/she may submit two different applications for Morning and Day shifts separately under single registration.
- Note: Applicants must not register themselves more than once. More than one registration by a single applicant will be liable to cancellation of candidature.**
2. Application will be considered valid only if applicant makes successful online submission of application form and upload the required documents. No alteration of marks will be entertained after the closure of online form submission. Applicant who fails to upload the required documents during online application will not be considered in the Merit List.
  3. If any listed applicant fails to deposit the fees online within the scheduled time, he/she will **not** get any further chance of admission in this college. Any request for admission without submitting required fees, mentioned above, will not be entertained.
  4. All admissions are provisional. Applicant will be treated as bonafide student of the college subject to verification of original documents following CU registration.
  5. Admission may be cancelled even after CU registration if the documents are found not in conformity with the declaration in the forms submitted online.
  6. The selected students must submit the following declarations at the time of verification:
    - (i) for attending classes regularly
    - (ii) for abiding by the anti-ragging regulations of the institution.
  7. **Applicants seeking reservation (SC, ST, OBC-A, OBC-B, PWD & EWS) facility must produce Applicable Reservation Certificate issued by the appropriate authorities within the state of West Bengal as on the date of application.**
  8. **Availability of Seats, as mentioned in the table, is subject to change as per the direction and order of Government of West Bengal from time to time.**
  9. **Applicable Admission Regulations and other notifications issued by the University of Calcutta from time to time governing UG admission procedures will be strictly adhered to.**
  10. All are requested to adhere to the COVID Norms / Protocol, issued by the Government from time to time.
